THE MONIES WILL NOT BE INVESTED UNTIL THIS INFORMATION IS PROVIDED AND FURTHER IT IS REQUIRED TRUST MONIES BE IN THE COURT REGISTRY FOR 10 WORKING DAYS PRIOR TO INVESTMENT.

In drafting the final judgement for trust funds, please leave a blank for the name of the banking institution in which the trust will be deposited. If not specified, the monies will be deposited in the County's depository at a lesser contracted rate of interest. (Chapter 117, Local Government Code.)
