To vote, completely fill in the oval to the left of your choice(s). Use pen or pencil. DO NOT ERASE. If you make a mistake you may request a new ballot. If your vote for a candidate or question is marked in such a manner that your intent is not clearly demonstrated, your vote for that office may not be counted. To protect the secrecy of your vote, do not put your name, initials, or any identifying mark on your official ballot.
STRAIGHT PARTY: You may cast a straight-party vote (that is, cast a vote for all the nominees of one party) by filling in the oval adjacent to the name of that party. If you cast a straight-party vote for all the nominees of one party and also cast a vote for an opponent of one of that party's nominees, your vote for the opponent will be counted as well as your vote for all the other nominees of the party for which the straight-party vote was cast.
