## John R. Roach Juvenile Detention Center

JC Kelly was asked to look at ways JDC could enhance officer performance and safety by researching trainings, referring to our Policy and Procedure requirements to implement with Training Coordinator Javier Arreola while also keeping cost low - all while maintaining his current workload as the JDC Training Officer/JSO/Fire Safety Officer.

JC Kelly and Javier were able to research and implement the following certified "In House" trainings while also saving money including travel time, hotel rooms, meals, per DM and travel reimbursements. JC Kelly was also able to meet with Homeland Security officials on potential issues of fire/inclement weather evacuation, external/internal threats, breaches of security and overall safety and compliance. A very important part of this was not having officers leave their families or modifying their work schedules.

1. Texas Juvenile Justice Department - Juvenile Supervision Officer Basic Training (40 hours) held in house in lieu of sending them to Huntsville, TX.
  2. Non-violent Crisis Intervention Training - Mechanical Restraints, Applied Physical Restraints (handcuffing/leg restraints).
  3. Bullying
  4. Emergency Preparedness – detailed review of P&P emergency procedures; fire, medical, natural disaster, escape routes, domestic, security disturbance. Actual "hands on" review/practice of emergency procedures for latter part of training hours in JDC.
  5. Prison Rape Elimination Act (PREA), Abuse Neglect Exploitation (ANE), Suicide Prevention Plan
  6. Documentation – enhanced writing, verbal skills applied, breaking up fights.
- Training – Implement practice/policy of all JDC Incident Reports with Physical/Mechanical restraints involved to be reviewed by Trainer JC Kelly for justification and appropriate practices and technique are followed through. This assists by allowing our training officer evaluate all restraints individually ensuring de-escalation techniques are being used properly. This lessons risk/liability of injury and maintains transparency of information while offering feedback.

Approved by TJJD to have Juvenile Probation Officer Basic Training on site. All officers will be dual certified JSO/JPO – only facility in the State that will have this distinction.

Working with Training Coordinator to generate CCJPD/JDC training manual by utilizing TJJD modules. Cost effective in lieu of paying outside entities.
