CPS, PPE, CASA, & Hopes Door To Receive Funding

During a September 14, 2004, regular session of the Commissioners Court of Collin County, Texas, a majority vote approved funding from the Family Protection Fees (GC 51.961) to go towards the following agencies: Child Protective Services (CPS), Practical Parent Education (PPE), Court Appointed Special Advocates (CASA), and Hopes Door.

Collin County Residents Now Able To Pay Fines Online

Taken from the McKinney Courier-Gazette, v. 107, no. 293 (Dec. 19, 2004) p. 1.

As of January 5, 2005, Collin County residents are now able to pay fines due to the justice of the peace courts online. This includes filing small claims, payment for health and other miscellaneous violations. This service has been provided by County officials in order to reduce the amount off calls the JP clerks take per day and also to make it easier for residents to make payments. This will also reduce any need to hire additional staff and to also meet the county's growing demands. In order to use the service, residents MUST be over 21 years old and have NO outstanding arrest warrants. Go to www.collincounty.tx.gov to see more.

New Rules For the Fifth District Court of Appeals

Excerpt from DBA Headnotes, v. 29, no. 1 (Jan. 1, 2005) p. 16.

These rules were approved by the Supreme Court of Texas on November 22, 2004. See the Dallas Bar Association Headnotes issue listed above to see entire article. Below is just a brief excerpt.

“**Rule 10:** A party must file the original and seven (7) copies of any brief submitted to the Court.”

“**Rule 11: Briefs in cross-appeals:** *Rule 11.1-* Civil appeal in which a cross-appeal has been timely filed; *Rule 11.2-* Aggregate number of pages for all briefs filed by any party may not exceed 125; *Rule 11.3-* Deadlines for filing briefs; *Rule 11.4-* If appellant or cross-appellant's appeal is dismissed and the appeal remains pending on the undismissed notice of appeal; *Rule 11.5-* The court may change the requirements of this rule on its own motion or motion of any party to the appeal.”



Check it Out: Law Library Circulation Policies

The Collin County Law Library is happy to permit attorneys and their legal assistants to borrow print, video, and some DVD materials from the library. Computer diskettes and CD-ROMs are the only items not available for check out; these items are licensed for use at the Law Library’s Attorney Workstation only.

To check out an item, simply complete a check out card located at the Reference Desk in the library and leave the completed card with the librarian.

Most items may be borrowed for up to 72 hours. Some of the more heavily used reference items must be returned within 24 hours. Some items that carry the 24-hour limit include *Vernon’s*, *The Texas Litigation Guide*, *O’Connor’s* pamphlets, and any items that contain forms.

We ask that attorneys be considerate of other users of the Law Library by returning materials promptly when they are due. **Remember:** The longer a book is checked out, the longer it is not available for other library users to use until you return it to the library. The ability of the Law Library to continue to offer this service depends upon attorneys returning materials in a timely manner.



Articles of Interest



“U.S Supreme Court Weighs In: Drunk Driving Is Not A Crime of Violence”

John A. Tarantino, Law & Science DWI Journal v. 19, no. 11 (November 2004), p. 1-5.

This article discusses the issue of whether a conviction for a DWI by a non-U.S. citizen can be labeled a “crime of violence”, which then is considered an “aggravated felony” that warrants deportation under the Immigration and Naturalization Act. There are multiple cases referenced in this article. Some examples include *Lee v. United States Attorney General*, 196 F.3d 1352 (11th Cir. 1999) and *Leocal v. Ashcroft*, 2004 WL 2514904.

“A TuneUp For Trial Presentations”

Brett Burney, Texas Lawyer v. 20, no. 43 (December 27, 2004), p. 27.

Mr. Burney gives attorney’s an easy to read (and brief) article about the importance of implementing technology into one’s trial presentation. Mr. Burney lists several types of software one can use (PowerPoint, Trial Director, & Sanction II). He also goes into the importance of selecting the right equipment (scanners, projectors, etc.) and their associated costs. For those wanting to “spice up” their presentations and leave a lasting impression on jurors, this is an excellent article on how to get started.

“Alter Ego Analysis to Find Hidden Assets”

Darrell D. Dorrell, American Journal of Family Law v. 18, no. 4 (Winter 2005), p. 213-233.

This article covers the topic of “solely owned entities” by husband and wife and how they’re affected during the dissolution of a marriage. Mr. Dorrell discusses the definition of “alter ego” and also discusses the topics of “Formal Alter Ego Relationships” and “Informal Alter Ego Characteristics”. Throughout the article he provides a list of related literature that readers may find helpful.

“Jurisdictional Issues”

Barbara Handschu & Mary Kay Kisthardt, The National Law Journal v. 27, no. 20 (January 24, 2005), p. 12.

This article discusses the issues of child custody and the problems that arise when the custodial parent moves out of state with the child and the matter of which state’s court has jurisdiction. It also discusses the 1997 Uniform Child Custody Jurisdiction and Enforcement Act (UCCJEA) and how it is interpreted by the states when it comes to the issue of how “home state” is defined and also the conflicts between the UCCJEA and the PKPA (Parental Kidnapping Prevention Act). Other topics covered include: Exclusive, continuing jurisdiction; Emergency or temporary jurisdiction; and, Interstate Enforcement.


