

Tips for Better Searching in Westlaw

Tired of wading through dozens of hits in your results list when using Westlaw? There are special symbols called Boolean Operators that you can use when entering your search terms that will help to make your search more specific. Clip and save this handy guide to searching with terms and operators!

Operator: &

Example:
conversion & automobile

This search will retrieve only those documents that contain both the word “conversion” and the word “automobile” within the same document

Operator: /s


Example:
conversion /s automobile

This search will retrieve only those documents that contain the word “conversion” and the word “automobile” within the same sentence

Operator: “ ”

Example:
“personal property”

This search will retrieve only those documents that contain the entire term “personal property” within the same document.

Unclaimed Faxes

The Law Library permits attorneys to receive faxes on the library's fax machine at a charge of \$1.00 per page. Lately, we have received many faxes addressed to attorneys that no one ever comes to pick up and pay for. We cannot continue to offer this service if the faxes are not retrieved and paid for in a timely manner. If you have a fax sent to the Law Library, **please pick it up** and pay for it within 24 hours.

Missing Newsstand Items

Lately, several items have gone missing from the Law Library's newsstand. These items are not free giveaway items available for people to take with them and keep; they belong to the Law Library and are kept there for everyone to use. Attorneys are welcome to read newsstand items while in the library. However, if you wish to take an item with you to read elsewhere in the courthouse or at home, we ask that you complete a check-out card and leave it at the Reference Desk.

Unpaid IOUs

The Collin County Law Library has always been happy to permit attorneys to leave an **IOU** with the librarian for the purchase of photocopies, print-outs, and faxes made in the Law Library. Attorneys are then invoiced at the end of each month for their IOUs.
