## Together, Law Librarians Mark 25 Years of Service

In February, Law Library Director Judy McCullough celebrated her **20th** year of service as law librarian for Collin County. Judy received her commemorative service pin from county Budget Director Rodney Rhoades in a meeting of Collin County Commissioners Court on February 13th.

“It has been exciting to serve Collin County for the past twenty years,” McCullough said. “We have gone from a library containing only books, a 30-inch desk, and a copier to one with Internet and Westlaw access for attorneys. Over the years, I have seen the library’s newsletter take shape and the creation of an online card catalog. Next: a move to a new courthouse, where the Law Library will provide even more access to justice, with more computer terminals and resources just waiting to be utilized. Thank you, Collin County, for all of your support.”

Assistant Law Librarian Katy Gill marked her **5th** year of service to the county in March, receiving her 5 year commemorative service pin. Both librarians look forward to serving the legal reference needs of the Collin County community in the years to come.



### Baker's FastLaws

It provides the full-text of the codes as well as helpful tables of amendments from the most recent legislature and the corresponding sections affected. Perhaps the best feature on FastLaws is the ability to search the full-text of the codes. The enhanced search feature not only offers keyword searching, but also the ability to search using Boolean operators.

## Check it Out: Law Library Circulation Policies

The Collin County Law Library is happy to permit attorneys and their legal assistants to borrow print, video, and DVD materials from the library. CD-ROMs are the only items not available for check out; these items are licensed for use at the Law Library’s Attorney Workstation only.

To check out an item, simply complete a check out card located at the Reference Desk in the library and leave the completed card with the librarian.

The more heavily used reference items must be returned within **24 hours**. Some examples of items that carry the 24-hour limit include the *Vernon’s* statutes, *The Texas Litigation Guide*, *O’Connor’s* pamphlets, and any items that contain practice forms. Other library items may be borrowed for up to 72 hours. When checking out materials, just ask a law librarian when the items need to be returned.

We ask that attorneys be considerate of other users of the Law Library by returning materials promptly when they are due. **Remember:** The longer a book is checked out, the longer it is not available for other library users to use until you return it to the library.

The ability of the Law Library to continue to offer this service depends upon attorneys returning materials in a timely manner.

**Where can I go to find the new Collin County Indigent Defense plans and forms?**

**Answer:**

At the Collin County Law Library!

The Collin County District Courts have adopted a new indigent defense plan effective January 12, 2007. This plan includes a **new fee schedule** for appointed attorneys in felony cases.

The Law Library has copies of the new indigent defense plans, including the new fee schedule, as well as the forms for requesting compensation. The plans for the County Courts at Law and the Juvenile Court are also available at the Law Library.

Attorneys may pick up copies of the plans and forms in the standing kiosk behind the large worktables in the Law Library.
