Free Online Storage

Judging from the number of thumb drives that we find left in the library, you may want to check out some online storage options. For those of you who are unaware, GoToMyPC.com does not work on the computers in the law library. However, Dropbox and Windows Live Skydrive do. Dropbox offers 2GB of free storage, and can automatically update changes in files made on different computers. Windows Live Skydrive offers 25 GB free storage, but is a little trickier to use. Both have the capability of "public access" for certain files, so you can share files with associates or assistants.

Both state and federal statutes govern the use of electronic recording equipment. This site was put together by and for journalists, but it is a nice summary of issues such as consent, expectation of privacy, and possession and publication.

Admissibility of Web-Based Data

The Advocate, Vol. 52 (Fall 2010) p.31-35.

This paper discusses the practical issues involved in using reports and records from the internet. The threshold issue in determining whether web-based data is admissible is authentication. Materials from government websites are self-authenticating under Texas Rules of Evidence 902(5), but material from private websites are more difficult. The article discusses various strategies for authentication and analysis under traditional hearsay rules.

Compassion Fatigue and Attorneys

Texas Bar Journal, Vol. 73, No. 8 (2010), p. 636-658.

Attorneys are ranked first on the list of occupations whose members are most depressed and prone to compassion fatigue (also known as burnout or secondary stress). Symptoms of compassion fatigue include substance abuse, overeating, anxiety, apathy, increased irritability, exhaustion and isolation. This article encourages attorneys to prevent compassion fatigue by developing a self care plan and establishing work-life balance. The author suggests that measures such as learning to set boundaries, cultivating creativity, and connecting with someone on a daily basis can help prevent and/or cure the issues that come with compassion fatigue.


Westlaw Tips: Access Old Statutes

Many attorneys ask to see old versions of Texas Statutes. You can access these through Westlaw. You can view statutes back to 2000 using the **Table of Contents** view by following these instructions:

Under **Statutes & Legislative Materials** section on the opening page, click on the **Table of Contents** view:




The page should look something like this:



Westlaw Tips: Access Old Statutes (continued)

The effective date in the right bottom corner of the screen will automatically default to the current date. You can change the effective date to any date back to Jan. 1, 2000. Just type it in MM/DD/YYYY format, and click on the Go button.



Now you will see a red **Archived Date** appear in the right bottom corner of the screen, letting you know that you are viewing archived content:

Now you can click on the section you need to expand the Table of Contents, and view the statutes.
