## Useful Internet Sites and Articles

### Siri Reviews

For all of you early-adopters and technophiles out there, Ben Schorr has written an interesting review on Siri, the voice-enabled personal assistant on the latest version of the iPhone. In his article "Siri—Can I Tell You a Secret?" Mr. Schorr points out that Siri has a security flaw—if someone gets possession of your iPhone 4S, they can "activate Siri and get her to do things like read your e-mail or send texts as you," even if you have the screen locked. ### Federal Case Law Search: PACER and Recap ([www.pacer.gov](http://www.pacer.gov) and [www.recapthelaw.org](http://www.recapthelaw.org))

PACER ([www.pacer.gov](http://www.pacer.gov)) is the federally funded website that "allows users to obtain case and docket information from federal appellate, district and bankruptcy courts." PACER is convenient, easy to use, and fairly inexpensive at 8 cents per page to access court documents.

If you use the Firefox browser, there is a plug-in available called Recap (PACER spelled backwards) that will automatically add any files you download to a free public archive, and will also let you know if any cases you are looking for are available for free from the archive. ### New Federal Register 2.0 Website ([www.Federalregister.gov](http://www.Federalregister.gov))

The Federal Register is the official daily publication of the US government and contains rules, proposed rules, and notices of Federal agencies and organizations, as well as Executive orders and other Presidential documents. Last year, the Government Printing Office and the National Archives Office launched an "unofficial" online version (the official version remains the printed paperbacks that the library gets every month). The website is user-friendly—the daily reports are indexed by "regular" language subject tabs such as "business and industry" and "science and technology" (although there is also a way to browse by agency, if you prefer). The navigation is easy and there are summaries, videos and headlines throughout the site.

### beSpacific ([www.bespacific.com](http://www.bespacific.com))

BeSpacific's banner reads "accurate, focused law and technology news," and I have to admit that this is one of the most useful news feeds to which I have ever subscribed. The daily email update includes links to reliable primary and secondary sources on a variety of subjects, including e-government, privacy, government documents, cybercrime and ID theft, the Patriot Act, freedom of information, federal legislation, and legal research.

## WestlawNext Tips

We have had very positive feedback on WestlawNext's usability compared to the regular Westlaw database. Here is a tip on using Next:

West has streamlined the interface so that you no longer have to look to find a citation box to use when you are trying to pull up cases. Using the main search box at the top of the screen, you can find a case by one or more of the parties' names, case title, or citation. If you have a list of citations you can type all of them into the search box, separated by semicolons, and Next will retrieve them all at once (see example below).



Also, please note: For your convenience, our version of Next has now been set to default to Texas and Federal jurisdiction—you no longer need to set the jurisdiction to Texas before searching for cases or statutes in our law library.
