471st District Court Calendar

The below dates are tentative and may change according to the Court's docket conditions.

ALL TRIALS: Agreed scheduling orders may be rejected if the initial trial setting is not within 12 months of the original filing date for Level 1 cases, 18 months of the original filing date for Level 2 cases, or 24 months of the original filing date for Level 3 cases. Pretrial/trial announcement will be held IN-PERSON at 10:00 am the Thursday before trial unless otherwise ordered by the Court. For JURY TRIALS, a notice of settlement WAIVING JURY must be announced on the record or e-filed with the District Clerk BEFORE pretrial, or failure to appear will result in dismissal of that party's claims.

HEARINGS: Hearings generally can be scheduled 30+ days out; please contact the Court for dates if you have a time-sensitive matter that requires an earlier setting. Once you have conferred with all parties, notify the Court of your preferred date to receive the exact time for your hearing notice.

EVIDENTIARY HEARINGS: If you plan to call live witnesses for a contested hearing (*i.e.*, other than default or minor settlement prove-ups), please alert the Court so that appropriate time can be set aside for your hearing. Generally, these fall on Wednesday and Thursday afternoons.

SUBMISSIONS: On the parties' agreement, any matter OTHER THAN discovery disputes or minor settlement prove-ups can be set by submission at 1:00 pm on any Court business day, at least 7 days out. Proposed orders MUST be e-filed at least 24 hours before the setting to ensure timely consideration.
