## PROCEDURES FOR OCCUPATIONAL DRIVER'S LICENSE

#### This form packet contains these documents:

- 1. Information on Obtaining Occupational Driver's License
- 2. Petition for Occupational Driver's License

- 4. Order for Occupational Driver's License

<u>Special Note</u>: Even if you get a court order for an Occupational Driver's License, DPS cannot issue one if you lost your driving privileges due to <u>any of the following reasons</u>:

- ➤ A medical condition,
- > Delinquent child support,
- > You have received two ODLs after a conviction in the past 10 years,
- You don't qualify to get a Texas driver's license because you are in the United States unlawfully. The documents to verify that you are a citizen or that you are in the United States lawfully are listed on the DPS eligibility link provided below.

#### Steps to Follow:

1. Check the status of your driver's license to learn if you are eligible for reinstatement of your current license instead of asking the court for an occupational driver's license. Check eligibility here: https://txapps.texas.gov/txapp/txdps/dleligibility/login.do.

2. Obtain an SR-22 Financial Responsibility Insurance Certificate. This is a special insurance policy for individuals in your position; it may be obtained from your auto insurance company. If you do not own a vehicle, you should ask an insurance provider about a Texas Non-Owner SR-22 Insurance policy.

3. Obtain a certified abstract (Type AR) of your complete Texas driving record from the Texas Department of Public Safety. Make sure all of your DPS records have been consolidated or you may have to purchase additional records.

- You may order your certified abstract (Type AR) <u>online</u>, pay the required fee (\$22.00), and print out the records at the following link: https://www.dps.texas.gov/DriverLicense/driverrecords.htm, OR
- You may order your certified abstract (Type AR) <u>by mail</u> by printing out the required driver record request form available at the following link: https://www.dps.texas.gov/DriverLicense/driverrecords.htm, completing it and submitting the required fee (\$20) to:

Texas Department of Public Safety PO Box 149008 Austin, Texas 78714-9008 4. Obtain proof of your need to drive. This might be a letter from your employer verifying your current work schedule, your paystub, a letter from your school registrar with your school schedule, or a sworn affidavit explaining to the court why you need to drive.

**Note**: you do <u>not</u> need to provide proof of essential need to drive if you have been convicted of an intoxication offense under Sections 49.04-49.08 of the Texas Penal Code or because of a court order or bond requirement.

## 5. Carefully read the Information on Occupational Driver's License and follow the instructions. This information has been provided by the Tayor Department of Public Software Disc

**instructions.** This information has been provided by the Texas Department of Public Safety. Please note that the fees reflected on this form are subject to change.

6. Prepare the Petition for Occupational Driver's License. The Petition is asking the court to order DPS to issue you an occupational driver's license. You may use this form as a "fill in the blank" if it fits your circumstances. If these forms do not fit your circumstances, you may re-type or re-write the forms, changing them to fit your circumstances, using the forms as a guideline. You will be assigned a case number and court when you file. *It is perfectly all right to hand-write the forms.* 

7. Sign the **Unsworn Declaration** on the Petition under penalty of perjury. (You could be criminally prosecuted for lying on this form.)

8. Attach a copy of the SR-22, certified abstract (Type AR) of your driver's record, and proof of your need to drive (if required) as exhibits to the Petition.

**9.** Prepare the Order Granting Occupational Driver's License, changing it to fit your set of circumstances. Only fill out the findings, section I, on the Order. Leave all other sections for the court to complete.

# 10. Make <u>two</u> additional copies of the prepared Petition with all attachments (SR-22, certified abstract (Type AR), and proof of your need to drive, if required) and Order to take with you when you file.

11. If your case was a misdemeanor, file the original Petition with the attached exhibits, Fiat and Order with the County Court at Law Clerk's Office located on the first floor of the courthouse at 2100 Bloomdale Road in McKinney. If the Judge does not automatically sign the Order, the clerk will arrange to have a hearing date set for you. You can check if a hearing has been set at <a href="http://apps.collincountytx.gov/cccasesearch/">http://apps.collincountytx.gov/cccasesearch/</a> and look up your case docket. If the Court signed the Order, go to step 16.

**12. If your case was a <u>felony</u>**, file with the District Clerk's office on the first floor of the courthouse located at 2100 Bloomdale Road in McKinney. At this time, give the Clerk the **Fiat** form. The Clerk will arrange to have a hearing date set for you.

13. You must send a file-stamped copy of the Petition with attached exhibits, completed Fiat with hearing date, and Order to the District Attorney's office. Mail the Petition and Fiat to the District Attorney via certified mail, return receipt requested to the following address:

Make sure to complete the **Certificate of Service** showing the date mailed. Once you have received the completed return receipt from the postal service, attach it to the completed Certificate of Service form and file this with the Clerk of the court.

14. If applicable, on your hearing date, bring the following with you to the hearing:

- A copy of your filed Petition for Occupational Driver's License with all attachments (the SR-22 certificate of liability insurance, certified abstract (Type AR) of your driving record and proof of your need to drive (if required)), and
- Your prepared Order for Occupational Driver's License

15. At the hearing, the following is recommended to properly address the Court:

"Good morning/afternoon, Your Honor. I am here to present my Petition for an Occupational Driver's License."

Summarize each paragraph of the <u>Petition</u> and give the prepared <u>Order</u> to the judge to be signed.

16. Send a copy of the signed Order to the District Attorney's office via certified mail, return receipt requested, at the address provided above.

**17. Send the required documents to DPS** <u>right away</u>. Send a certified copy of the Petition, a certified copy of the SIGNED Order Granting Occupational Driver's License, your original SR-22 insurance certificate and any fees to the address provided in the Information on Obtaining Occupational Driver's License and follow the instructions for delivery methods and inclusions.

18. It may take approximately four weeks for the Department of Public Safety to issue an occupational driver's license. A certified copy of the signed Order Granting Occupational Driver's License will serve as the license up to 45 days after the order takes effect until the DPS sends you the official occupational driver's license in the mail. If you don't receive your occupational driver's license before the 45th day after your Order takes effect, do not drive until you receive the occupational driver's license OR until you go back to court to get an amended order extending the deadline.

## After you receive the license from the DPS, you must carry the following in your vehicle at all times:

- 1. The occupational driver's license
- 2. The SR-22 insurance certificate
- 3. A certified copy of the Order Granting Occupational Driver's License

## Information on Occupational Driver License

This information provided by the Texas Department of Public Safety

## What is an Occupational Driver License?

An occupational driver license, also called an essential need license, is a special type of restricted license issued to you when your driver license has been suspended, revoked or denied for certain offenses, other than a medical reason or delinquent child support.

Note: If you have been suspended as a result of a surcharge assessment, you may still qualify for an occupational driver license.

An occupational driver license authorizes you to operate a non-commercial motor vehicle only in connection with:

- 1. Work,
- 2. School-related activities, or
- 3. Performance of essential household duties.

## **Request an Occupational Driver License**

You must petition the Justice of the Peace, county or district court where you currently reside, or to the court of original jurisdiction where the offense has occurred, to obtain an occupational driver license.

Upon reviewing your petition, if the court determines you are eligible to apply for an occupational driver license, you will be provided with a signed court order. This court order is not the occupational driver license. You must submit the court order to the Texas Department of Public Safety (DPS) along with the other necessary documentation for the issuance of an occupational driver license.

## **Issuance of an Occupational License**

The court order and all required items must be submitted to DPS before an occupational license will be issued. The court order may be used as a driver license for 45 days from the date of the judge's signature while the request for an occupational license is processed.

You must submit the following items to DPS:

- 1. A certified copy of the petition and a certified copy of the court order granting the occupational license.
  - a. The judge has the authority to grant an occupational order.
  - b. If you are participating in a special drug court program, the petition is not required.
- 2. A Financial Responsibility Insurance Certificate (SR-22).

A Financial Responsibility Insurance Certificate (SR-22) is required by the Texas Transportation Code Chapter 601 to verify that you are maintaining motor vehicle liability insurance. You should contact your local insurance agent or provider to obtain a SR-22. If you do not own a vehicle, you should ask an insurance provider about a Texas Non-Owner SR-22 Insurance policy.

- 3. Payment of the occupational license fee. New or renewal \$10 per year issued up to two years. (Must pay reinstatement fees first. See Step 4.)
  - a. An occupational license is typically issued for one year or less; the maximum length of issuance is two years.
  - b. The court must grant the issuance of an occupational license beyond one year.
- 4. Payment of all Reinstatement fees. You may pay reinstatement fees at the following link:

https://txapps.texas.gov/txapp/txdps/dleligibility/login.do

**Important**: Once you are issued an occupational driver license, you are only permitted to operate a motor vehicle within the terms of the court order. You must keep your court order in the vehicle with you at all times and present it along with your occupational driver license upon demand by a peace officer.

## Waiting Period

An occupational license will be issued <u>once the request is processed</u>, unless one of the following situations applies *and* the judge has not ordered the waiver of the waiting period:

- 1. Your driver license was previously suspended as a result of an alcohol or drug-related offense. There is a <u>90-day waiting period</u>.
- 2. Your driver license was in suspension as a result of an intoxication-related conviction. There is a <u>180-day waiting period</u>.
- 3. There are at least two administrative license revocations on your driver record. There is a mandatory <u>one-year waiting period</u>.

#### **Denial of Issuance**

An occupational driver license cannot be issued for purposes of operating a *commercial motor vehicle* during a period of:

- License suspension,
- Revocation,
- Cancellation, or
- Denial

If you do not receive your Occupational Driver's License from the Texas Department of Public Safety (DPS) before the 45th day after the date this Order takes effect, you must not drive until you receive your Occupational Driver's License from Texas Department of Public Safety or come back to court to get an Amended Order for Occupational Driver's License that extends the 45-day time period.

If this Order includes a finding of an essential need to drive, and the places, reasons, days or times that you need to drive change, you must come back to Court to get an Amended Order for Occupational Driver's License that reflects those changes.
