Application Checklist

Payment to the US Department of State for the Passport – See fee info. on back page.

- **Must be a mailable form of payment made payable to: U.S. Department of State**
Examples: Check, Money Order or Cashier's Check – **Must be exact amount. No exceptions**
- Each application must have its own Check, Money Order or Cashier's Check.

All applicants and minor applicant's parents must be present

Minors **under** the age of **16** must:

- be accompanied by both parents or
- submit a notarized statement of consent form (DS-3053) with a copy of the front **and** back of the identification presented to the notary. The form must be the original – no copies.
- submit a **certified** copy of a court order giving exclusive rights to apply for the child's passport and or giving sole custody to the parent who is present

16 & 17 year olds:

- must be accompanied by one parent **or** submit the original notarized statement of consent form (DS-3053) with a copy of the front **and** back of the identification presented to the notary

Original proof of U.S. Citizenship

- Valid/Expired U.S. Passport
- Certified/Original U.S. Birth Certificate
- Certificate of Naturalization/Citizenship/Consular Report of Birth Abroad

Valid form of Identification

- State DL/State ID/ U.S. Passport Book or Card/Foreign Passport

Passport Photo *Photo services available on site for \$16*

Payment to the District Clerk's Office for processing the application

- The \$35 processing fee stays with the District Clerk's office and can be paid with cash, check, money order or credit card (no American Express). Checks/Money Orders should be **payable to: Collin County District Clerk's Office**. Multiple processing fees can be combined into one payment.
