As you know, on September 30th, 2024 and in accordance with Section 4.3 of the Agreement for the Provision of Firefighting and Fire Protection Services ("Agreement") between Collin County ("County") and the City of McKinney ("City") - misidentified in the Agreement as the McKinney Fire Department, the City of McKinney provided notice of the City's intent to terminate the Agreement effective October 1, 2025.

After careful consideration and discussion with the McKinney City Council, the City Council has voted to continue the provision of firefighting and fire protection services for an additional 1-year period, ending October 1, 2026.

AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL
AGREEMENT WITH COLLIN COUNTY FOR EMERGENCY SERVICES
FOR FY2026**

WHEREAS, the City Council of the City of McKinney, Texas, desires to continue providing emergency services to Collin County for an additional one-year period from October 1st, 2025 to September 30th, 2026.

WHEREAS, The City of McKinney Fire Department has provided emergency services to Collin County for a one -year period ending September 30th, 2025.

WHEREAS, an additional one-year provision of emergency services to Collin County is requested due to a pending election in November 2025 for the creation of an Emergency Services District.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:


Section 1. The City Council of the City of McKinney, Texas, hereby authorizes the city manager to enter an interlocal agreement with Collin County for emergency services.

Section 2. Emergency Services provided to Collin County will be for a one-year period from October 1st, 2025 to September 30th, 2026.

Section 3. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
