Measles Exposure in Collin County

Collin County Health Care Services has been notified that an individual who spent time in Collin County from May 19th through May 22nd has tested positive for measles. This individual visited four public venues while infectious.

Exposure Locations & Dates:

- 24 Hour Fitness, 1601 North Hardin Boulevard, McKinney, Texas 75071
 - Date: 5/19/2025, between 4:30 PM – 9:00 PM
 - Date: 5/21/2025, between 3:30 PM – 7:30 PM
- Moviehouse & Eatery, 8450 State Highway 121, McKinney, Texas 75070
 - Date: 5/19/2025, between 6:30 PM – 11:00 PM
- Cubana Grille, 4051 South Custer Road Suite 1160, McKinney, Texas 75070
 - Date: 5/20/2025, between 3:30 PM – 7:30 PM
- Market Street, 6100 Eldorado Parkway, McKinney, Texas 75070
 - Date: 5/22/2025, between 4:00 PM – 10:00 PM

Collin County Health Care Services is collaborating closely with the Texas Department of State Health Services to monitor this situation.

Measles is a highly contagious disease that can be transmitted from person-to-person through the air or contaminated surfaces. Measles can remain in the air for up to two hours after an infected person has left the area. Measles can lead to serious health complications.

If you were at any of these locations during the specified dates and are not vaccinated against measles or are unsure of your immunity, you may be at risk of contracting measles.

What You Should Do:

1. If you were at one of the venues on the dates and times listed above and are:
 - Unvaccinated and pregnant; or
 - Immunocompromised (receiving treatment that would result in immune system suppression, or have an immune system disease),It is recommended that you contact your health-care provider immediately to discuss the possible exposure.
2. Anyone who was at the venues on the dates listed above should monitor themselves for measles symptoms through June 12, 2025. Those symptoms include:
 - Fever
 - Dry cough
 - Runny nose
 - Sore throat
 - Inflamed eyes (conjunctivitis)
 - Koplik's spots: Small white spots with bluish-white centers found inside the mouth
 - A skin rash made up of large, flat blotches

3. If you develop symptoms of measles:

- Stay home and away from others.
- Contact your healthcare provider for guidance.
- Call before visiting a clinic or hospital to prevent possible exposure to others.

Collin County Health Care Services emphasizes that the most effective way to prevent measles is through vaccination with the measles, mumps, and rubella (MMR) vaccine.
