Re: Investment Report – 4th Quarter (FY 2019)

On September 30, 2019, total invested operating, non-operating, and capital project funds of Collin County had a market value of \$639,992,570. As required by Collin County's Investment Policy and in accordance with Government Code 2256, all investments were made with the following objectives in order of priority. First, the safety of the principal and maintenance of adequate liquidity were given the highest consideration. Second, diversification was accomplished by investing county funds into five separate PFIA investment pools (LOGIC, Texas Class, Texas TERM, TexPool and TexSTAR), as well as by purchasing Certificates of Deposit, Federal Agency Bonds, and Municipal Bonds. Collin County is working to achieve even more diversification by purchasing US Treasuries to further strengthen portfolio.

The weighted average maturity (WAM) for investments was 0.474 years, and weighted yield to maturity (YTM) was 2.200%, which compares to 0.846 WAM and 1.965% YTM for prior year 4th quarter.

During the FY2019 4th quarter, our overnight pools and cash equivalent investments experienced a seasonal decrease from the prior quarter by \$79,035,237, due primarily to the timing of property tax receipts. Certificates of Deposit experienced an increase by \$9,649,009 and Bonds decreased by \$7,617,490.

Bond investment activity during the quarter consisted of one bond called, nine bonds matured, and 11 bonds purchased. The total interest earned for all investments during this quarter totaled \$3,653,374.

Attached is our Collin County Quarterly Investment Report which consists of a Statement of Investment Position, a Summary Statement by Group, Investment Details, and Schedules of Investments by Fund.

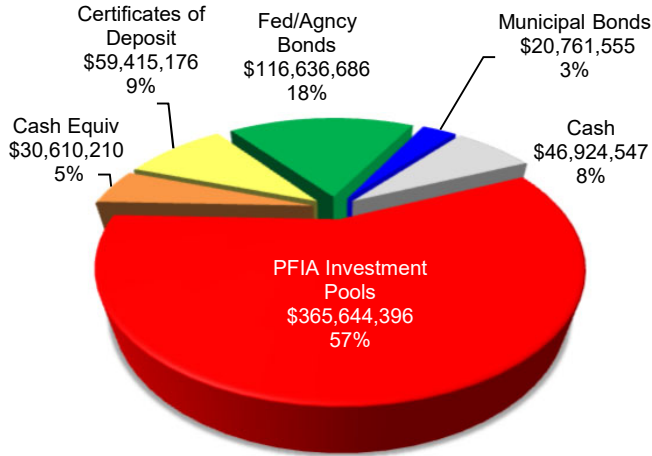

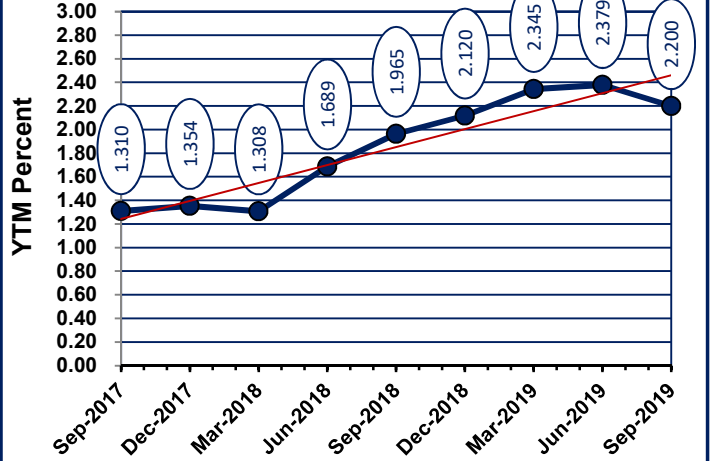

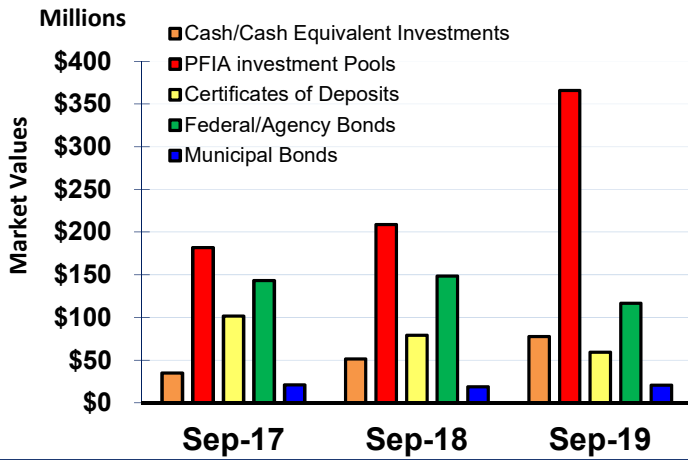
Portfolio Composition by Type



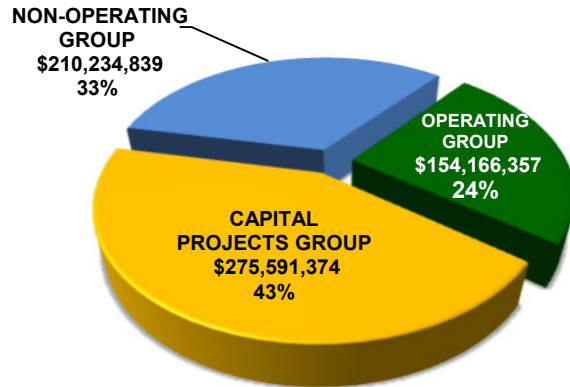
**Portfolio Weighted YTM
2 Year Trend**



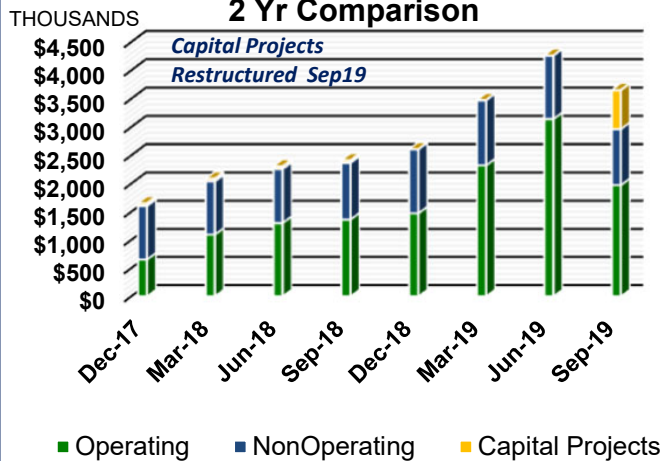
**Portfolio Position by Type
3 Yr Comparison**



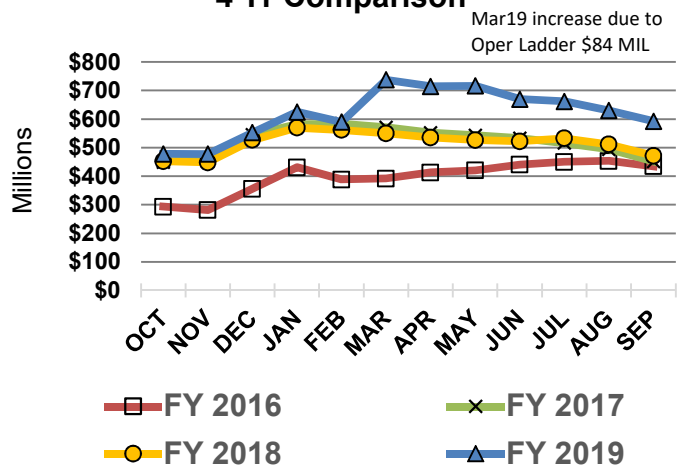
**Portfolio Composition by

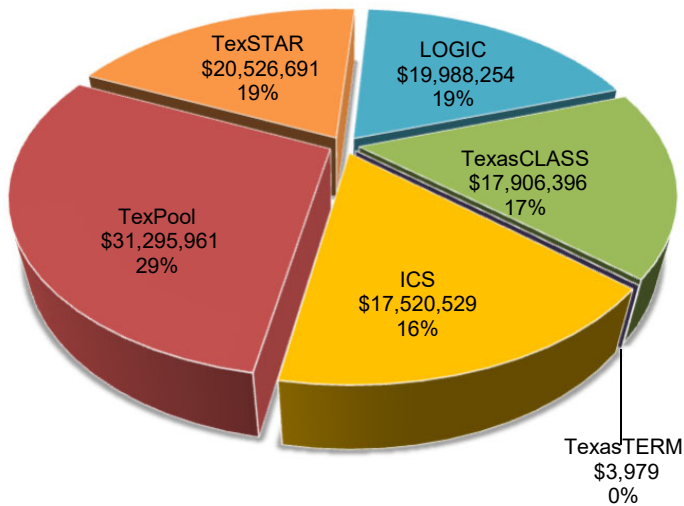

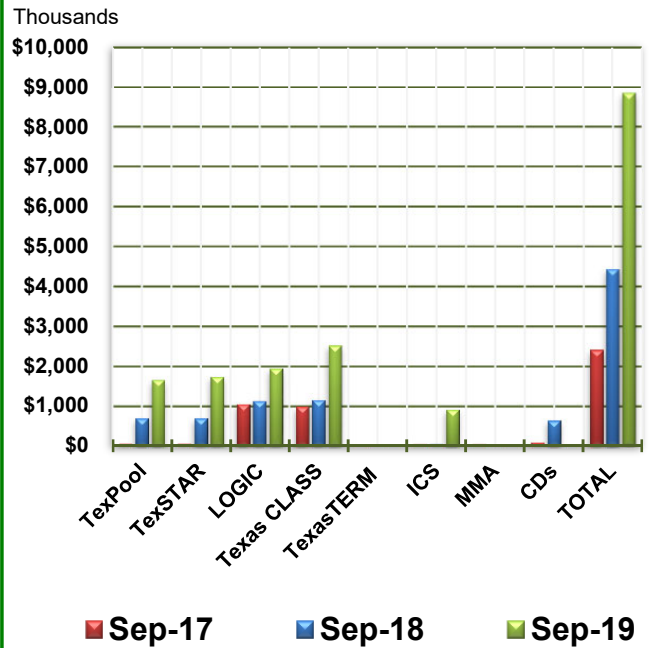

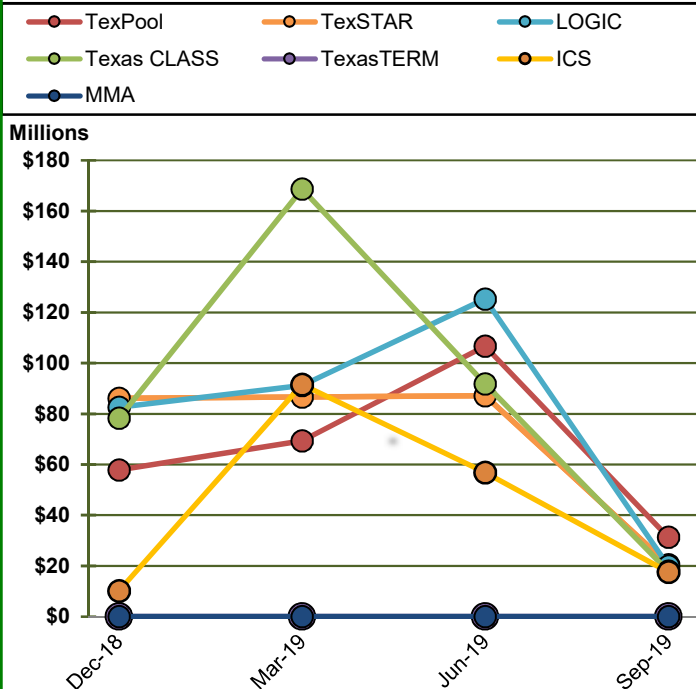
Operating Investments by Type at Quarter End



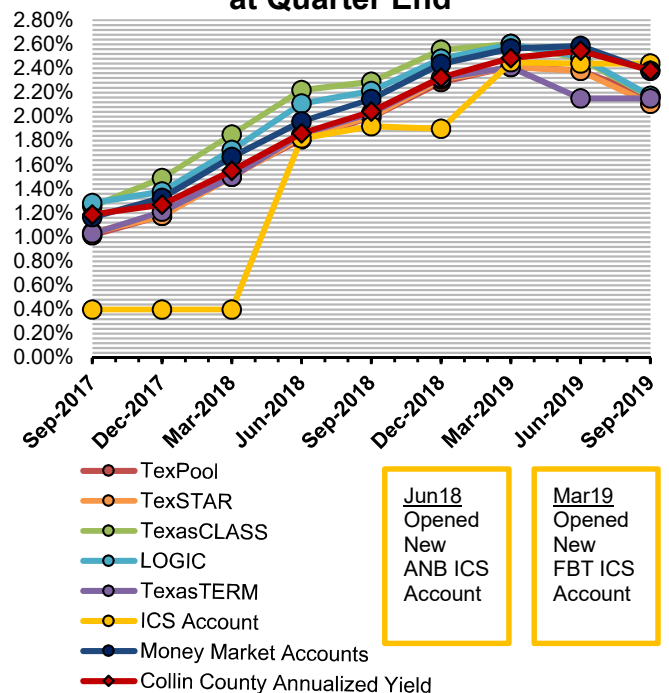
Operating Investments YTD Interest Earnings Comparison at Quarter End

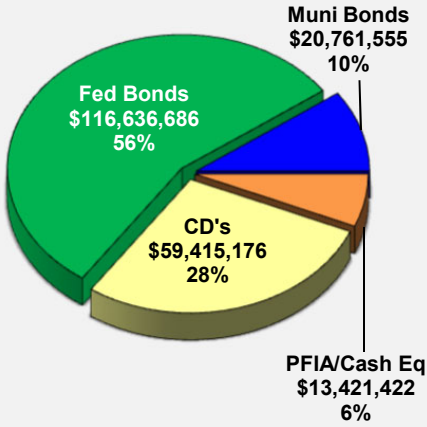

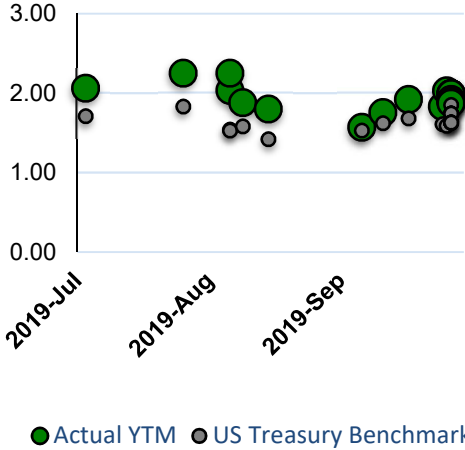

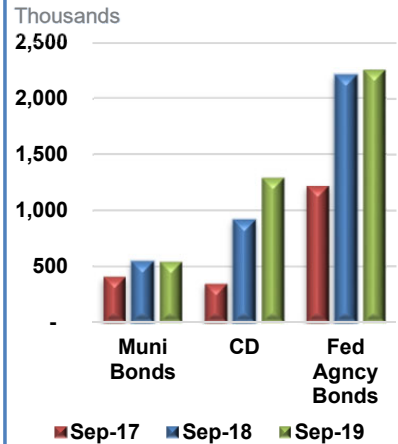
Non-Operating Investments by Type at Quarter End



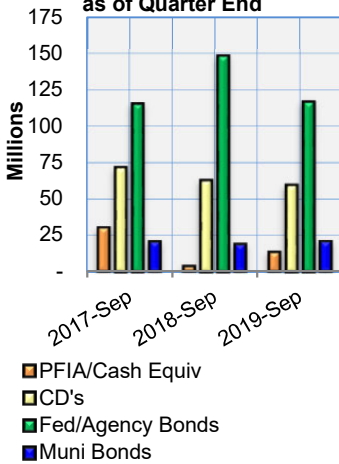
Non-Operating Purchases YTM vs US Treasury



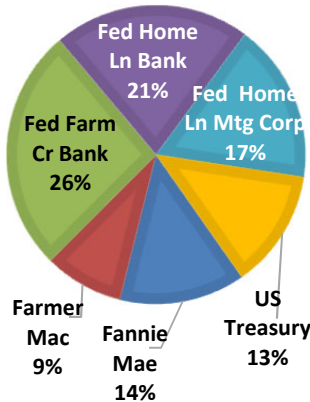
Non-Operating YTD Interest Earnings Comparison at Quarter End



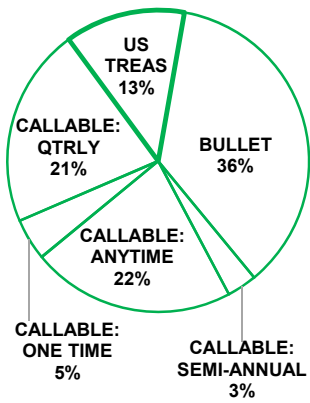
Non-Operating Investments Three Year Comparison as of Quarter End



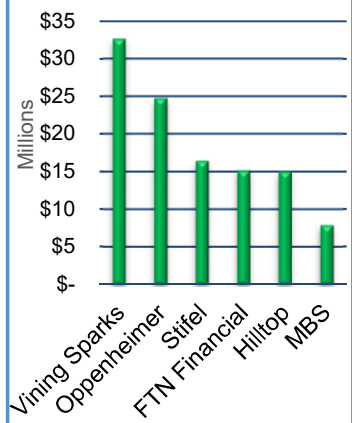
Federal Agency Bonds Breakdown by Issuer



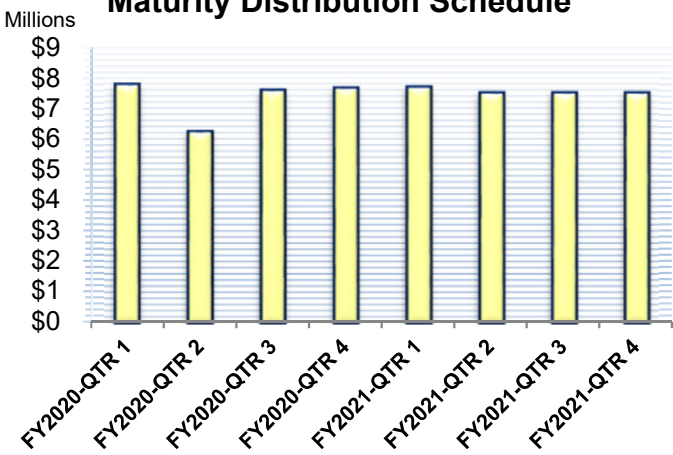
Fed Agency Bonds Breakdown by Type



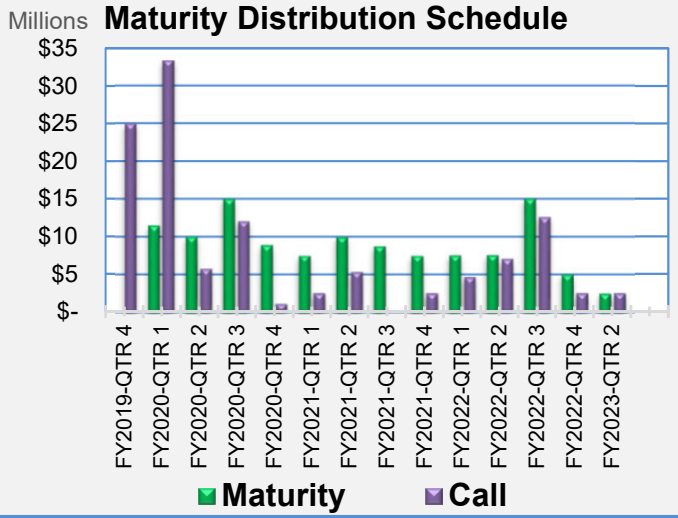
Federal Agency Bonds Breakdown by Current Broker/Dealer

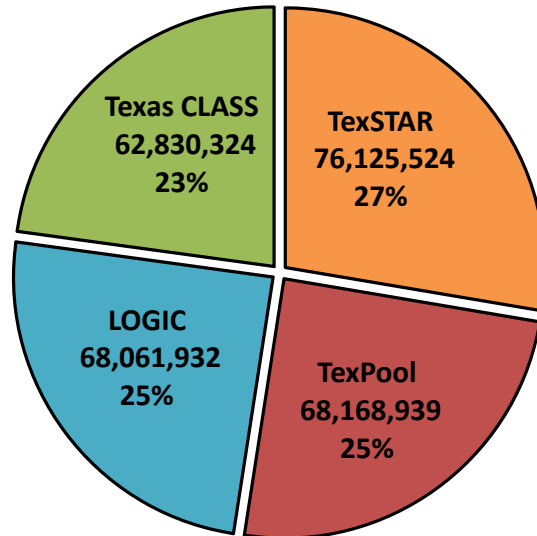
