**COLLIN COUNTY TEXAS, COUNTY COURTS AT LAW'S
CRIMINAL MISDEMEANOR FEE SCHEDULE
(AS AMENDED JUNE 1, 2026)**

(All Amendments to the Fee Schedule are effective immediately and apply to all outstanding and future claims.)

The County Court at Law Judges of Collin County, Texas hereby adopt the following Fee Schedule for the appointment of attorneys in misdemeanor criminal cases.

**Payments to Court Appointed Attorneys Fixed Rates
Counsel shall be paid:**

1. Plea Agreements

- \$750.00 for a dismissal, or for a plea on a driving while intoxicated case plus \$100.00 for each additional case pled arising out of the same transaction.
- \$650 for a dismissal, or for all non-driving while intoxicated pleas plus \$100.00 for each additional case pled arising out of the same transaction;

2. Trials and Appeals

- \$2,500.00 for a jury trial of any case, including a motion for new trial.
- \$1,250.00 for a trial before the court of any case.
- \$2,500 for the appeal of any case, including motions for rehearing.
- \$1,000.00 for a dismissal or plea at the time of trial (not at the arraignment).

3. Expunctions

- \$250 for Expunctions as required by the Code of Criminal Procedure.

4. Motions

- \$250 for Motions to Withdraw.
- \$250 for Refusals.
- Motions to Adjudicate and Motions to Revoke: compensated at the original plea rate (see above).
- Motions to Suppress: included within the representation, no additional fee allotted.
- Motions to Substitute Counsel (pre and post-information cases): Compensation at the Judge's discretion, not to exceed the flat rate (see above).
- Motions involving violations of bond/bond modifications on filed cases are considered part of the representation. No separate fee is paid. Pre-information bond hearings, including bond insufficiency, bond violations, and bond reduction \$250.

5. Pre-Information Disposition

- \$250 for the first case plus an additional \$100 for any additional charge arising out of the same transaction.

6. MHMC Case Pleas

- Compensated at the flat rate for DWI or Non-DWI plea (see above).
- MHMC Cases with a Continuity of Care designation: Compensated at the flat rate of \$950.00 for DWI cases and \$850.00 for Non-DWI cases.
- \$250 for Competency Hearing.
- \$250 for MH Bond Hearing.

7. Pre-Trial Diversion (PTD)

- Payment is remitted upon placement in PTD. If the PTD ends unsuccessfully, it will be considered a new appointment.

8. Unapprehended Defendants

- If a warrant has been issued and the defendant remains unapprehended for (6) months or more, attorneys may file a motion to withdraw and submit a pay sheet for \$250.
- If the defendant is rearrested, the same attorney will be reappointed if the defendant qualifies and the attorney remains on the appointment wheel.

9. Billing for Experts (Private Investigator & Testifying Experts)

- Invoices must be submitted via the pay portal. The attorney must complete the pay sheet, mark "Pay to Expert," attach the invoice, and include any related court orders. The attorney must sign the pay sheet to verify services were provided.

10. Other Experts (Non-Testifying, Consultants, Interpreters, Reporters, Immigration Attorneys, Competency Experts)

- Invoices must be submitted to the court coordinator for payment by check.
- The attorney must sign the invoice to indicate approval and verification of services rendered.
