**SUPPLEMENTAL ORDER REGARDING TRIAL PROCEEDINGS,
MEDIA ACCESS, SECURITY, AND COURTROOM DECORUM**

On May 18, 2026, this Court entered its **Amended Order Regulated Trial Proceedings, Media Access, Security, and Courtroom Decorum** ("Amended Order"). The Court finds that clarification of that Order is necessary to ensure the orderly administration of justice throughout the pendency of these proceedings.

Accordingly, IT IS HEREBY ORDERED:

1. **Continued Effect of Prior Orders.** The Court's **Amended Order Regulated Trial Proceedings, Media Access, Security, and Courtroom Decorum** entered on May 18, 2026, shall remain in full force and effect throughout the duration of this Court's jurisdiction over this matter unless modified by further order of the Court. All parties, counsel, spectators, and any other persons subject to the Amended Order shall continue to comply with all its provisions.
2. **Public Information Officer.** For any upcoming hearings or proceedings in this matter, Russell Schaffner is designated as the Court's Public Information Officer ("PIO"). All media inquiries, requests concerning media access, and communications regarding courtroom procedures and media coverage shall be directed through the Court's designated PIO, unless otherwise ordered by the Court. 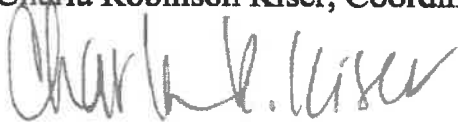
