

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FRISCO, COLLIN AND DENTON COUNTIES, TEXAS, ORDERING A GENERAL ELECTION TO BE ADMINISTERED BY THE COLLIN COUNTY ELECTIONS ADMINISTRATOR AND THE DENTON COUNTY ELECTIONS ADMINISTRATOR ON MAY 2, 2026, FOR THE PURPOSE OF ELECTING THREE MEMBERS OF THE FRISCO CITY COUNCIL (MAYOR AND PLACE NOS. 5 AND 6) TO FILL EXPIRING TERMS; DESIGNATING EARLY VOTING POLLING PLACES AND HOURS; DESIGNATING ELECTION DAY POLLING PLACES AND HOURS; DESIGNATING FILING DEADLINES; ORDERING NOTICES OF ELECTION TO BE GIVEN AS PRESCRIBED BY LAW IN CONNECTION WITH SUCH ELECTION; PROVIDING FOR THE APPOINTMENT OF ELECTION JUDGES AND CLERKS; AUTHORIZING THE MAYOR AND CITY SECRETARY TO TAKE ALL ACTIONS NECESSARY TO COMPLY WITH APPLICABLE ELECTION LAWS; AND PROVIDING A SAVINGS/REPEALING CLAUSE, SEVERABILITY CLAUSE AND AN EFFECTIVE DATE.**

WHEREAS, the City Council of the City of Frisco, Texas (“City Council”) duly authorizes and hereby orders a general election to be held within the City of Frisco, Collin and Denton Counties, Texas (“Frisco”) on May 2, 2026, for the purpose of electing three members of the Frisco City Council (Mayor and Place Nos. 5 and 6), with each such term being for a period of three years.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FRISCO, TEXAS:**

SECTION 1: Findings Incorporated. The findings set forth above are incorporated into the body of this Ordinance as if fully set forth herein.

SECTION 2: General Election Ordered. A general election (“Election”) is hereby ordered to be held on Saturday, May 2, 2026 (“Election Day”), for the purpose of electing three members of the Frisco City Council (Mayor and Place Nos. 5 and 6) to fill expiring terms. The Election shall be administered by the Collin County Elections Administrator and the Denton County Elections Administrator. The Collin County Elections Administrator shall administer the Election for the Collin County portion of Frisco, and the Denton County Elections Administrator shall administer the Election for the Denton County portion of Frisco. Frisco voters shall vote in the county in which they are registered.

SECTION 3: Early Voting.

Collin County Voters: Early voting by personal appearance shall be available at: Collin College, Frisco Campus, Room J113, 9700 Wade Boulevard, Frisco, Texas 75035; Fire Station No. 8, Training Room, 14700 Rolater Road, Frisco, Texas 75035; Fire Station No. 5, Training Room, 14300 Eldorado Parkway, Frisco, Texas 75035; The Grove at Frisco Commons, Game Room C, 8300 McKinney Road, Frisco, Texas 75034; or the Collin County Elections Office, 2010 Redbud Boulevard, Suite #102,

McKinney, Texas 75069, which is designated as the main early voting polling place. Early voting will begin on Monday, April 20, 2026, and continue through Tuesday, April 28, 2026, during the normal working hours of 8:00 a.m. to 5:00 p.m., with extended voting hours on Saturday, April 25, 2026, from 8:00 a.m. to 5:00 p.m.; Monday, April 27, 2026, from 7:00 a.m. to 7:00 p.m.; and Tuesday, April 28, 2026, from 7:00 a.m. to 7:00 p.m. There will be no voting on Tuesday, April 21, 2026, and Sunday, April 26, 2026. Applications for ballots by mail shall be requested from and mailed to Kaleb Breaux, Early Voting Clerk, 2010 Redbud Boulevard, Suite 102, McKinney, Texas 75069, or faxed to 972-547-1996, or emailed to [absenteemailballoting@collincountytx.gov](mailto:absenteemailballoting@collincountytx.gov). (If faxed or emailed, the original application must be mailed and received within 4 days.) Applications for ballots by mail must be received no later than the close of business on April 20, 2026.

Collin County voters may vote at any of the additional Early Voting locations open under full contract services with the Collin County Elections Administrator, which may be designated after February 13, 2026. This previous sentence shall also be posted in the Notice of Election. Early voting times and locations are subject to change.

Denton County Voters: Early voting by personal appearance shall be available at: Fire Station No. 4, Training Room, 4485 Cotton Gin Road, Frisco, Texas 75034; Fire Station No. 7, Training Room, 330 W. Stonebrook Parkway, Frisco, Texas 75036; Fire Station No. 6, Training Room, 3535 Eldorado Parkway, Frisco, Texas 75033; the Denton County Government Center, Community Room, 5533 FM 423, Frisco, Texas 75036; or the Denton County Elections Office, 701 Kimberly Drive, A111, Denton, Texas 76208, which is designated as the main early voting polling place. Early voting will begin on Monday, April 20, 2026, and continue through Tuesday, April 28, 2026, during the normal working hours of 8:00 a.m. to 5:00 p.m., with extended voting hours on Saturday, April 25, 2026, from 8:00 a.m. to 5:00 p.m.; Sunday, April 26, 2026 from 11:00 a.m. to 5:00 p.m.; Monday, April 27, 2026, from 7:00 a.m. to 7:00 p.m.; and Tuesday, April 28, 2026 from 7:00 a.m. to 7:00 p.m. There will be no voting on Tuesday, April 21, 2026. Applications for ballots by mail shall be requested from and mailed to Frank Phillips, Early Voting Clerk, Denton County Elections, PO Box 1720, Denton, TX 76202, or faxed to 940-349-3201, or emailed to [elections@dentoncounty.gov](mailto:elections@dentoncounty.gov). (If faxed or emailed, the original application must be mailed and received within 4 days.) Applications for ballots by mail must be received no later than the close of business on April 20, 2026.

Denton County voters may vote at any of the additional Early Voting locations open under full contract services with the Denton County Elections Administrator, which may be designated after February 13, 2026. The previous sentence shall also be posted in the Notice of Election. Early voting times and locations are subject to change.

#### SECTION 4. Election Day Voting.

Collin County Voters: Election Day voting by personal appearance shall be at the following locations, and any of the additional Election Day Vote Centers open under full contract services with the Collin County Elections Administrator, from 7:00 a.m. to 7:00 p.m.

**SECTION 5: Filing Deadlines.** Candidates must file for a specific place and adhere to the filing deadlines. Candidate packets are available in the City Secretary’s Office, 6101 Frisco Square Blvd., Frisco, Texas 75034. The candidate filing periods for the Election are as follows:

Beginning: January 14, 2026, at 8:00 a.m.  
Ending: February 13, 2026, at 5:00 p.m.

**SECTION 6: Voting Equipment and Materials.** For early voting in person, early voting by mail, election day voting and provisional voting, the following voting equipment will be used in Collin County: ES&S Ballot on Demand printers and software, ExpressVote Universal voting machines (EVS 6.1.1.0), ES&S DS200 ballot counters (EVS 6.1.1.0), ES&S Model DS450 and DS850 High-Speed Scanners/Tabulators (EVS 6.1.1.0), along with the required ancillary parts and services required for such voting tabulation system and ADA compliant headphones, keypads, voting signs, and election supply cabinets. For early voting in person, early voting by mail, election day voting and provisional voting, the following voting equipment will be used in Denton County: Hart InterCivic, Verity Scan 2.7.6 and Print and Access Writers 2.7.1, a ballot-on-demand paper balloting system, along with the required ancillary parts and services required for such voting tabulation system.

**SECTION 7: Election to Comply with Applicable Laws.** The City Secretary is hereby authorized and directed to publish and/or post, in the time and manner prescribed by law, all notices required to be so published and/or posted in connection with the conduct of this Election. The Election and notice of the Election shall be conducted in accordance with the Texas Election Code and other applicable law, and all qualified and registered voters of Frisco shall be eligible to vote at the Election.

**SECTION 8: Appointment of Election Judges and Clerks.** The appointment of the Presiding Election Judges, Alternate Judges, Early Voting Clerks, the Presiding Judge of the early ballot board and other election officials for the Election shall be made by the Elections Administrators in accordance with the contracts for election administration services and the Texas Election Code. The Elections Administrators may employ other personnel necessary for the proper administration of the Election,

including such part-time help as is necessary to prepare for the Election, to ensure the timely delivery of supplies during early voting and on Election Day, and for the efficient tabulation of ballots at the central counting station.

SECTION 9: Authority of Mayor and City Secretary. The Mayor and the City Secretary, in consultation with the City Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Texas Election Code and any other state or federal law in carrying out and conducting the Election, whether or not expressly authorized herein.

SECTION 10: Severability. Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional and/or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. The City Council hereby declares that it would have passed this Ordinance, and each section, subsection, clause and phrase thereof regardless of whether any one or more sections, subsections, sentences, clauses or phrases may be declared unconstitutional and/or invalid.

SECTION 11: Savings/Repealing. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict. Any remaining portion of conflicting ordinances shall remain in full force and effect.

SECTION 12: Effective Date. This order for an election becomes effective immediately upon its passage.
