

## **ORDINANCE NO. 2026-002**

AN ORDINANCE OF THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT OF COLLIN COUNTY, TEXAS, ORDERING A GENERAL ELECTION TO BE ADMINISTERED BY THE COLLIN COUNTY ELECTIONS ADMINISTRATOR ON TUESDAY, NOVEMBER 3, 2026, FOR THE PURPOSE OF ELECTING TWO (2) CANDIDATES TO THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT; APPROVING THE JOINT GENERAL AND SPECIAL ELECTION SERVICES CONTRACT WITH THE COLLIN COUNTY ELECTIONS ADMINISTRATOR; DESIGNATING THE COLLIN COUNTY ELECTIONS ADMINISTRATOR AS CUSTODIAN OF VOTED BALLOTS AND ELECTION MATERIALS FOR THE TIME PROVIDED BY LAW; DESIGNATING EARLY VOTING DATES AND POLLING LOCATIONS; MAKING PROVISIONS FOR THE CONDUCT OF A GENERAL ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE.

IT IS ORDERED BY THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT THAT:

SECTION 1. A General Election is hereby ordered to be held on Tuesday, November 3, 2026, for the purpose of electing two (2) qualified candidates to the Board of Directors of Wylie Northeast Special Utility District (the "District").

SECTION 2. The Board of Directors of the District approves of and agrees to the Joint General and Special Election Services Contract (the "Elections Contract") pursuant to which the Elections Administrator of Collin County, Texas (the "Elections Administrator"), will administer the General Election. The General Manager of the District is hereby authorized to execute the Elections Contract for and on behalf of the District.

SECTION 3. Applications for a place on the ballot may be delivered to the District's administrative offices located at 745 Parker Road, Wylie, Texas, or mailed to the District at P.O. Box 1029, Wylie, Texas 75098. Personal delivery will only be accepted during the District's regular office hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. The deadline to file an application is Monday, August 17, 2026, at 5:00 p.m.

SECTION 4. The Elections Administrator is hereby appointed the Early Voting Clerk for the General Election. The Early Voting Clerk shall supervise and conduct early voting by mail and in person for the General Election and shall provide additional personnel to serve as early voting clerks. Early voting by personal appearance begins on Monday, October 19, 2026, and ends on Friday, October 30, 2026. SECTION 5. Applications for absentee ballots (a/k/a ballots by mail) for the General

Election may be downloaded at <https://webservices.sos.state.tx.us/forms/6-1f.pdf>. Completed absentee ballot applications must be mailed or delivered to the *Collin County Early Voting Clerk, 2010 Redbud Blvd., Suite 102, McKinney, TX 75069*, or faxed to (972) 547-1996, or emailed to [absenteemailballoting@collincountytexas.gov](mailto:absenteemailballoting@collincountytexas.gov). Absentee ballot applications will be accepted by the Collin County Early Voting Clerk until 5:00 p.m. on Friday, October 23, 2026. Completed absentee ballots must be received by 7:00 p.m. on November 3, 2026 or Wednesday, November 4, 2026 at 5:00 p.m., if the carrier envelope is postmarked by November 3, 2026 at 7:00 p.m.

SECTION 6. The General Election shall be conducted in accordance with applicable provisions of the Texas Election Code and the attached Elections Contract. All qualified and registered voters of the District shall be eligible to vote in the General Election.

SECTION 7. The District's Election Agent is hereby authorized and directed to publish or post all notices prescribed by law in connection with the General Election ordered hereby.

SECTION 8. The attached Order of General Election is hereby approved.

SECTION 9. The Elections Administrator or qualified persons appointed by the Elections Administrator will serve as election judges to conduct the General Election.

SECTION 10. The Collin County Elections Administrator is hereby appointed the custodian of voted ballots and shall retain all General Election materials of the District for the time-period specified by law.

SECTION 11. The President and Secretary of the District, in consultation with District legal counsel, are hereby authorized and directed to take any and all actions necessary for the District to comply with applicable provisions of the Texas Election Code and any other state or federal law in carrying out and conducting the General Election, whether or not expressly authorized herein.

SECTION 12. For and on behalf of the District, the General Manager is hereby authorized to execute the standard Contract for Election Services with the Collin County Elections Administrator to administer the General Election.

SECTION 13. This Order of Election shall take effect and be in full force from and after the date of its passage until the General Election is cancelled or completed.

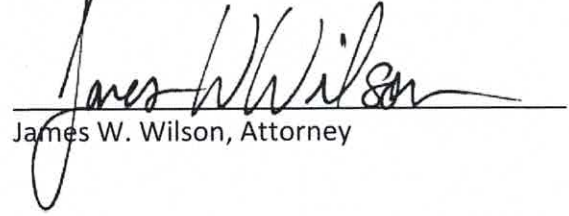
