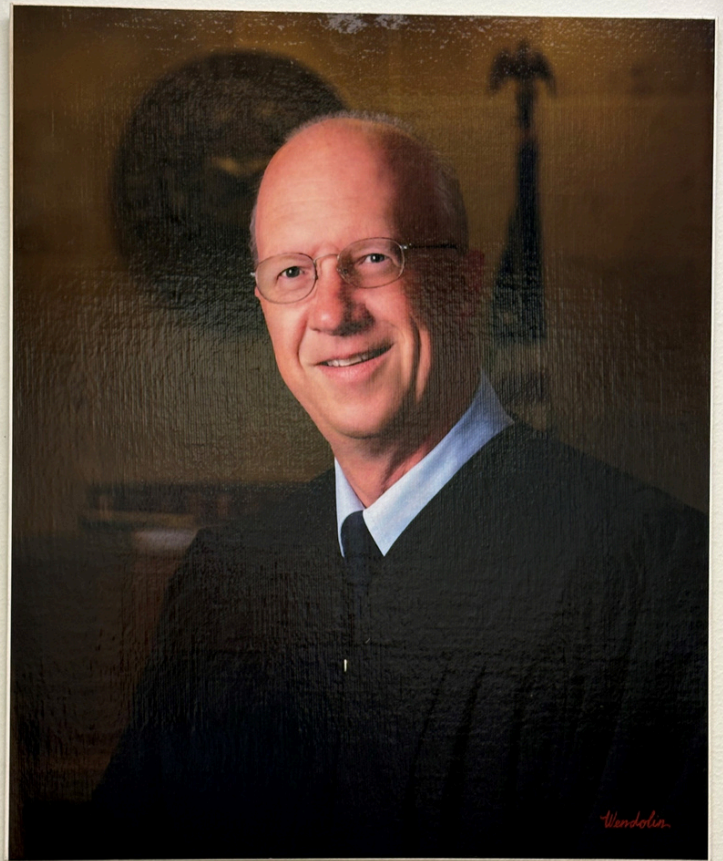


Honoring Judge Curt B. Henderson

Upon Judge Henderson's retirement in 2010, the Collin County Commissioners named the County Law Library the Curt B. Henderson Law Library. In 2011, the Collin County Bar Association inaugurated the Curt B. Henderson Inn of Court, Collin County's affiliation with the American Inns of Court system. Judge Henderson presided over thousands of cases, and more than 680 jury trials in his 25 years as a trial judge. It was an honor and privilege to interview Judge Henderson for "The Information Edge," the Curt B. Henderson Law Library's quarterly newsletter.

Honoring Judge Curt B. Henderson – continued

Judge Henderson kindly responded to our questions in writing:

Dear law library patrons,

Serving as a District Judge in Collin County was one of the great privileges of my life and career. When I graduated law school and entered the workforce (initially as a prosecutor), I never in my wildest imagination could I have dreamed of becoming a District Judge.

The favorite part of my experience as judge were trials by jury. A jury trial embodies the best representation of the American legal/judicial system. During the jury selection process, potential jurors are educated about our system by excellent and experienced attorneys who have to overcome years of misinformation and unfounded myths about the trial process.

My emphasis as a district judge was to make sure that there was the highest level of confidence in the process taking place in the courtroom. For the most part my job as judge was not to determine outcomes, but rather to manage the case, control the tone of the courtroom and make sure the parties and attorneys appearing before me followed longstanding and accepted rules of procedure and evidence. And to that end, I insisted that the participants presented competent evidence that aided the jury in reaching their verdict and acted with proper decorum: dignified and respectful. While some may think that's old fashioned, it was my experience that jurors welcomed and appreciated the dignity and respectful behavior of the participants.

After I retired from the bench I did a few years of mediation work and visiting judge assignments. My wife and I also traveled extensively; seeing all those places you would want to see and experience if you had the time and means. In 2018 my wife and I moved to Houston to be near our grandchildren, which has been a great decision. We had previously purchased a second home in Colorado and spent a great deal of our summers there.

I continued to work part-time as an arbitrator until the 4th of July 2025, a date I will never forget because on that day my wife took me to the emergency room at the local hospital near our home in Colorado. I was told that I had brain tumors and an aggressive form of brain cancer. So that journey with MD Anderson Cancer Center began immediately and that journey continues to this day.

Even today, as I reflect, I am grateful for the trust that the community placed in me back in 1988, and for the many lawyers, clerks, and staff members who made the work of the court meaningful. I am also immensely honored to have the law library named after me. I had no clue that the naming was in the works and was very surprised and honored when it was announced. I have not been inside the Collin County Courthouse since 2010. I'm sure it is a much different place from the place I knew, with different faces and priorities and challenges.

I've been asked to leave a bit of advice to the new young lawyers. First, become an excellent lawyer who is always prepared, and exhibit professionalism and integrity Find out who the great local lawyers are and ask if you can shadow them on a case. Treat everyone with dignity and respect."

DOJ, VA Sign Agreement to Implement Guardianship Process for Veterans

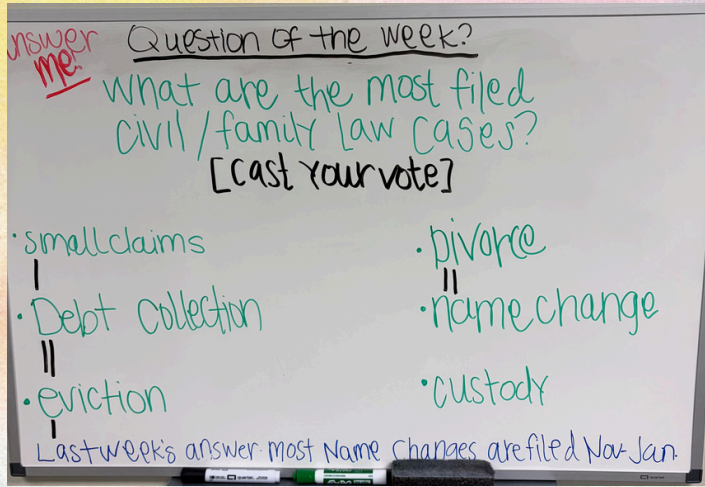
The U.S. Veterans Administration has implemented a new Guardianship process via a Memorandum of Understanding (MOU) between the VA and the U.S. Department of Justice (DOJ).

The MOU gives the DOJ the authority to appoint VA attorneys as Special Assistant U.S. Attorneys. That appointment will give VA attorneys the legal authority to initiate and participate in state court guardianship or conservatorship proceedings when required for Veterans.

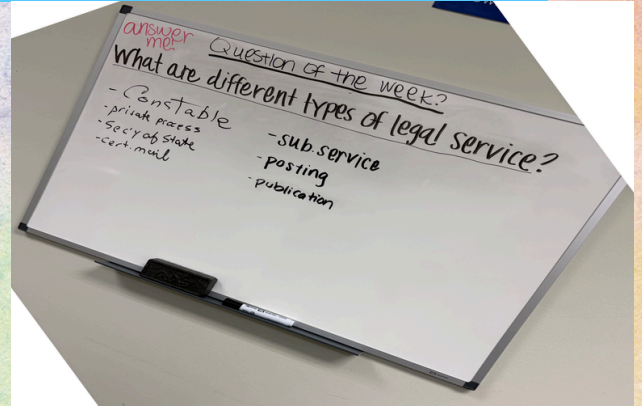
