




**An order of the Collin County Emergency Services District No.1**

On Monday, March 30, 2026, the Collin County Emergency Services District No. 1 Board of Commissioners met in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4<sup>th</sup> Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating to wit:

The meeting was called to order by Commissioner Kevin McGillis at 5:00 p.m.

Public Comment - The ESD Board of Commissioners heard comments from Mr. Richard Hill.

Item No. 1 - The ESD Board of Commissioners considered the approval of the February 23, 2026 Meeting Minutes. A motion was made by Commissioner Shinn to approve the minutes. The motion was seconded by Commissioner Robinson, and was approved 4-0. [2026-010-03-30]

Item No. 2 - The ESD Board of Commissioners discussed the approval of the Tax Collection Services Agreement with the Collin County Tax Assessor-Collector. Commissioners agreed to hold the item until the next ESD meeting.

Item No. 3 - The ESD Board of Commissioners discussed the approval of submission of New Governmental Organization to the Collin County Appraisal District. A motion was made by Commissioner Shinn to direct staff to perform all necessary tasks to register with the Collin County Appraisal District as soon as possible, including authorizing the President to sign any agreement with the Appraisal District. The motion was seconded by Commissioner Robinson and was approved 4-0. [2026-011-03-30]

Item No. 4 - The ESD Board of Commissioners discussed the approval of the Interlocal Agreements with cities, volunteer fire departments, and other Districts for fire and/or emergency services. Commissioner Robinson requested a discussion. Commissioners agreed to hold the item until the next ESD meeting.

Item No. 5 - The ESD Board of Commissioners discussed the approval of an emergency and ambulance service contract with American Medical Response, Inc. Princeton Fire Chief, Shannon Stephens, provided a statement on their daily operations and management of the American Medical Response contract. John Hodges, American Medical Response Director of Operations, provided a statement of their services. Commissioners agreed to hold the item until the next ESD meeting.

Public Comment - The ESD Board of Commissioners heard comments from Mr. Richard Hill.


Item No. 6 - The ESD Board of Commissioners discussed the Fiscal Year 2026 Budget and the April 27, 2026 meeting location. A motion was made by Commissioner Shinn to move the location of the April meeting to McKinney Fire Station No. 10, 1150 Olympic Crossing, McKinney, Tx 75071. The motion was seconded by Commissioner Robinson and was passed 4-0. [2026-012-03-30]

Item No. 7 - The ESD Board of Commissioners discussed Safe-D Memberships. Commissioner Robinson made a motion that Collin County ESD No. 1 joins Safe-D and the president and staff are authorized to execute what is necessary for the membership. The motion was seconded by Commissioner Shinn, and was approved 4-0. [2026-013-03-30]

Item No. 8 - The ESD Board of Commissioners discussed the establishment of the ESD website. There was no action taken.

Item No. 9 - The ESD Board of Commissioners discussed future agenda items and meeting topics.

Commissioner McGillis adjourned the meeting at 6:04 p.m.
