

*Upon further investigation one case of WNV Non-Neuroinvasive, it was determined not to be a case.

Vector Index for West Nile Virus

The Vector Index is calculated by multiplying the average number of mosquitoes collected per trap night by the proportion infected with West Nile Virus, and is expressed as the average number of infected mosquitoes collected per trap night in the area during the sampling period. (CDC) Vector Index can be used to alert public health officials of an increasing number of infected mosquitoes and the optimal time for early intervention.
