JOINT STATEMENT REGARDING HEALTH AND SAFETY CONCERNS

The Collin County Justice of the Peace Justice Courts recognize the unease about a potential outbreak of COVID-19 (Novel Coronavirus). The health and safety of employees, attorneys, litigants, and the public remain our outmost concern. The Justice Courts are committed to doing their part to address these anxieties and will utilize the following rules until April 1, 2020. This end date may be extended if necessary.

1. If a Person is Sick

Everyone who is sick or who thinks they have been exposed to COVID-19 should contact the court to re-schedule their hearings or trials

2. Non-Essential Court Matters are Rescheduled

All non-essential court functions will be rescheduled during the above time frame. All functions of the Justice Court are considered non-essential unless they effect the safety of a person or persons; or, are statutorily required to be completed. If you have any matters that you deem are essential, please contact the court.

3. No Jury Trials

The Justice Courts will not hear jury trials during the time period noted above.

4. Justice Court Websites
