### PROCEDURES FOR NAME CHANGE OF FAMILY Both Parents as Petitioners

#### **Steps to Follow:**

- 1. Prepare the Original Petition for Change of Name of Family, keeping the basic format shown. You may use this form as a "fill in the blank" if it fits your set of circumstances. Otherwise, you should re-type or re-write the Petition, including the information that applies to your personal set of circumstances; leave out that which does not. You will be assigned a case number and court when you file. Sign the declaration on this form under penalty of perjury. (You could be criminally prosecuted for lying on this form.)
- 2. Have any of the children that are ten years of age or older sign the Consent forms.
- 3. Fill out the Civil Case Information Sheet completely.
- 4. Make two additional copies of the completed Original Petition and any signed consent forms needed for your case before filing. (You do not need a copy of the civil case information sheet.)
- 5. File the Original Petition and Civil Case Information Sheet in the District Clerk's office on the first floor of the courthouse at 2100 Bloomdale Road in McKinney. If any of the children are ten years of age or older, file the child's signed Consent forms with the District Clerk at this time. You will be required to pay a filing fee to the Clerk at this time. The clerk will file-stamp the original and copies with the date and time, and return the copies to you.
- 6. You will be required to get fingerprints taken and sent to the Texas Department of Public Safety (DPS) for a background check. Information on how to do this is attached. After the fingerprint cards have been sent to DPS, wait 6 weeks, then call the District Clerk's office to see if the cards are in your file. If so, ask the clerk when you can come to see the judge and finish up your case.
- 7. Prepare the Order Granting Name Change prior to the hearing.

8. At the hearing, you will state the facts of your petition as shown on the Sample Prove Up sheet. The judge will not help or ask questions. Give the Order Granting Name Change to the judge to sign after he or she hears the Prove Up.

## SUBMISSION OF FINGERPRINT CARDS TO DPS/FBI FOR LEGAL NAME CHANGE

The Texas Family Code, Section 45.102, requires that each petition include a legible and complete set of the petitioner's fingerprints on a fingerprint card format acceptable to the Department of Public Safety (DPS) and the Federal Bureau of Investigation (FBI).

WHERE TO GET FINGERPRINTS TAKEN: The petitioner may call 1-888-467-2080 to schedule an appointment to be fingerprinted at a "Print and Go" FAST location or access the website at <a href="https://www.identogo.com">www.identogo.com</a> and select Option B — Fingerprint Cards. Fingerprints <a href="mailto:cannot">cannot</a> be transmitted to DPS electronically. The fee for this fingerprinting service is \$20.00, includes two fingerprint cards. Petitioner must submit both fingerprint cards and all required information to DPS by mail.

FEES: Under the authority of Chapter 411.088, Texas Government Code, DPS charges a \$15.00 fee and the FBI a \$12.00 fee for processing State and Federal background checks. A cashier's check, certified check, personal check or money order made payable to Texas DPS in the amount of \$27.00 must be attached to the fingerprint cards, along with a copy of the court petition.
